Shoreline Master Program – Recommendation to Council.

Mr. Bond explained that replacement pages 20 & 21 of the Shoreline Master Program were handed out at this meeting. He gave a brief summary of the various corrections and changes requested by the Commission and made to the Shoreline Master Program draft. He explained that he felt that the document was ready to go before the Town Council. The map has been corrected and now reflects the Van Eaton property located west of town and is now owned by the Nisqually Land Trust. He added that the Nisqually Land Trust also owns land in the town's watershed.
