APRIL AND MAY 2015 REPORT

### *Special Events and Traffic Assignments*

- The speed limits entering the Town of Eatonville on SR161 and exiting near Smallwood Park have been lowered by the Washington State Department of Transportation.
  - The new speed zone signs have been flagged for high visibility and we are continuing to educate the public through contact and warnings. We are not planning to use enforcement for the time being, unless the speed is high enough to warrant the enforcement action (higher than old speed limit).
  - The portable radar speed trailer is being repaired
  - The new Speed Monitor mounted to the sign by Lynch Creek Rd has been well received and I have gotten many positive comments of it being a perfectly placed to remind drivers of their speed as they enter Town

### *Public Safety Committee Requests*

- The Public Safety Committee is reviewing the following E.P.D. requests;
  - Physical speed reduction measures {EPD driven}:
    - Should speed reduction measures {speed bumps or humps} be placed adjacent to the Skate Park, Playground and Recycle Center area to physically slow vehicle traffic 24/7?
    - Our hope is the physical speed reduction measures in this area will create a safer recreational play area for our residents. This road is commonly used by vehicles to bypass the downtown area and the 4 way stop intersection.
    - Pending...
  - Residential speed limits {EPD driven}:
    - Current E.M.C. has reduced the speed limit in most of our residential areas to 15mph. State law places the speed limit in all incorporated towns and cities at 25mph, unless posted otherwise.
      - In order to enforce the speed zones at lower than 25mph, there needs to be two things; statutory authority and the

lower speed limit signs must be posted to alert the citizens of the change. The E.M.C. has been changed, but no mandatory signs have been posted.

- The question to the Public Safety Committee – Does the Council want to keep the speed limits at 15mph {mandatory signage needed}, or reset the statutory speed limits to 25mph, aligning with state speed limits {E.M.C. needs to be changed}?
  - Currently, the only speed limit that is legally enforceable is 25mph
- Commercial Truck Parking {EPD/citizen complaints driven}:
    - Do we need to update the Semi parking E.M.C.'s to align the Council's intent with the needs of the community, or is current E.M.C. sufficient?
    - Semi parking with truck attached has no parking time restrictions.
    - Semi parking with no truck {trailer only} has a 24 hour limit.
      - An option is to consider aligning the semi parking E.M.C. with the R.V. code...parking is restricted to 24 hours anywhere in Town, with an extension permit available.
        - The need for review is caused by a semi truck and trailer parking on Washington adjacent to the Bakery, with citizen complaints of it causing traffic obstruction and distraction during school drop off and pick up periods {current E.M.C. allows this with tractor attached to trailer}.
        - In March, I talked to the semi driver to ensure he was aware he had a 24 hour parking restriction if he detached his truck, leaving the trailer parked on Washington. He said he wants to work within the Town's wishes and will comply.
        - I've seen no violations since March
- All Terrain Vehicles on Public Roadways {Mr. Donnie Stewart request at Council Mtg}:
    - Can properly equipped All Terrain Vehicles be allowed to operate on the public roadways of the Town of Eatonville?
    - Washington has changed the state laws to allow properly equipped and licensed ATVs to operate on public roadways outside of incorporated Towns and Cities.
    - Decision Point: Change the E.M.C. to bring our statute into alignment with state law, allowing it...or; not change the E.M.C. or allow our residents to operate their properly equipped ATVs on the Town's roadways?
    - Pending...

## Upcoming Events

- Eatonville resident Marya Severson-Urich, the great great granddaughter of Eatonville Town Marshal Dolar LaPlant {killed in the line of duty in 1925} and other relatives have been working with EPD to submit Dolar for the prestigious Washington State Medal of Honor in 2015.
  - The recommendation package was submitted in January and he was awarded the medal in March, 2015
  - The Tacoma News Tribune printed an article on February 15, 2015, highlighting the effort by the family to not only honor Dolar with the Medal of Honor, but to fund a new headstone at the Woodbine Cemetery in Puyallup that accurately reflects and honors his sacrifice.
  - The Tacoma/Pierce County Crime Stoppers organization has agreed to fully fund the new headstone costs. They have also invited Dolar's relatives to be guest speakers for the 2015 Law Enforcement Memorial Service at Clover Park Technical College Auditorium, scheduled for 6:00 P.M. on Wednesday, May 6<sup>th</sup>, 2015. LaPlant's great granddaughter, Ronda Snowden, was one of the guest speakers at this event.
  - Update: The Washington State Medal of Honor will be awarded to the family on Saturday, May 9 at 1300 hours at Woodbine Cemetery in Puyallup. The above mentioned headstone will also be installed and dedicated at the same time. Mayor Schaub, Officer McGuire and I will attend to represent the Town of Eatonville.

## Performance Plan

- The Performance Plan is a Problem Oriented tool that is used by departments to address quality of life issues within their communities.
  - Emphasis of the Week
    - During April and May, our continued focus will be crime prevention patrols.
    - Vacation checks can be requested by contacting Gaille or any officer and filling out the request and information form.
  - We are currently working with the Rod Knockers and Fourth of July Parade planning teams to help manage their upcoming events.
  - We continue to monitor the Bud Blanchard Trail system and develop strategy to manage new issues and patrol it effectively and efficiently. We have seen the trail system develop into a very positive destination location for the Town.

- Pierce County 911 Service Contract
  - The contract has continued to work well. Through this contract, the department has been able to lower overtime costs while maintaining service.
    - For number of calls billed, please refer to the calls for service summary of this report.
    - We have had two Officers take vacation/sickleave over the past 2 months and as a result of this contact, we have not seen a marked increase in overtime backfill costs or decrease in service.
- South Sound 911 Dispatch and Report Service Contract
  - We are still fine tuning the new radios, radio dispatch, computers in the cars and report writing system, but it is working well to date and we are now tied into the region, both with radios and reports.

### ***Training***

- For 2015, the officers will participate and receive their 60 hours of on-going training with the Pierce County Sheriff's Department Training Unit, who provides regional certified training at no cost to their regional partners.
  - Includes 40 hours of in service training {legal updates, emergency vehicle operation, defensive tactics, active shooter and advanced patrol tactics, first aid to include the AED and other necessary topics}.
  - Includes twenty hours of firearms, tactics and lethal force training {2 ten hour training days, one summer and one winter}
  - This training criteria, topics and amount of hours exceeds the standards set by the industry and meets the professional training best practices.

### ***Management Activities***

- The review of the current Policies and Procedures Manual is continuous.
- The 2015 Budget is operational.
- The 2015 Department Training Plan is operational.
- The Town Emergency Management Plan and Hazard Mitigation Plan is being revisited and updated in cooperation with Eatonville Fire and Emergency Management.


