charges from time to time; now, therefore,

BE IT RESOLVED, by the Town Council of the Town of Eatonville as follows:

Section 1. The late payment fee for utility services shall be fifteen dollars (\$15.00).

Section 2. Reconnection fees for utility services shall be in addition to late payment fees
and all other charges, and shall be as follows:

1. Payment of all past due charges, including reconnect fee,
made by 4:00 p.m. on a Town business day for reconnection
on the same day. \$ 25
2. Payment of all past due charges, including reconnect fee,
made after 4:00 p.m. p.m. on a Town business day, \$ 100
3. Payment of all past due charges, including reconnect fee,
made after 2:00 p.m. p.m. on a Town business day, or by
special arrangement on a non-business day, for
reconnection on the next Town business day \$ 25
4. Additional charge for electrical service disconnected at the
pole rather than at the meter box \$ 50

Section 3. The tampering charge for reconnection of utility service by other than Town
personnel shall be five hundred dollars (\$500.00).

Section 4. REPEALER. Resolution 1999-OO is repealed in its entirety.
